    it an inviting feel.
  - Issues of concern:

- i. We used to have page sponsors and we won't be able to do that as well. It would just be a text list of the names of the sponsors without logos.
- **ii.** We might be able to have a scrolling list of prizes below and list who gives the prizes, but again no logos.
- **iii.** We need to look at the wording on the site where it says, "Anonymous" and "Full Disclosure" and "Notify Charity" to make this clearer.
- **iv.** Consider a pop-up window to give folks the chance to be taken directly to the click and give website...maybe do this each Monday.
- v. Need approval from agencies, IT folks, Administrators, etc...
